**PAR Consulting Teacher:** Hourly rate of pay (based on teacher's base salary). Not to exceed \$2,665 per year.

**BTSA Support Provider:** \$2,665 per participating teacher per year.

**Longevity:** A stipend of \$1,500 per year is offered to all employees at the completion of the 25th consecutive year of employment with the District. After the completion of 30 consecutive years of employment with the District, a \$3,000 stipend is offered.
